- 4. President's Report Verbal report given. Not a lot to report, most is covered in the GM's report.
- 5. Treasurer's Report Verbal Report given. Draft financial presented for 2018. Overall revenue is up and expenses are down so a good year. The net is estimated to be around \$15K once all adjustments are made. Account balances: Op account \$9141, Capital account \$14357, GIC \$5000. Discussion on what GIC is for. Action: Shaun will look into history of GIC so board can decide whether to cash it in and move it to the Capital account.

8. Committee Reports

Will be organizing a spring clean up prior to course opening and finish the burn behind 8^{th} tee box. Received a quote from Signed to set up and number parking spots in private cart area and want to construct and assign spots. Discussion on offering discounts to volunteers who help with clean up.

Golf Course Development – Justin Bailey – nothing to report

Tournaments – Clem Hand – discussion on RBC Scramble, has the potential to be the strongest tournament draw at the course Action: Matty & Clem to formalize next steps, dates & times for tournament. Date is believed to be July 20th, 2019.

Midnight Tournament – Hughie Graham – first meeting of the year is February 27th with Canadian North. Looking for other opportunities for sponsorship depending on how much Canadian North can offer. May be challenges on F & B costs now that it is contracted out.

Rules and Handicaps – John Nahanni – is gathering new rules and will send out a draft. It was identified that the committee still needs to discuss the multiple mat issue presented at the AGM. Discussion on putting in a local rule regarding balls bouncing off of rocks surrounding aprons. Action: Committee to present a summary of new rules as well as a decision on playing with multiple mats in a round. Also to present a possible rule regarding balls bouncing off of rocks.

General Managers Report

Pro-Shop -

Not a lot to report on for the Pro-Shop, still working on getting all the order confirmations from the different companies we ordered from in October.

Staff have started to be hired for the Pro-Shop, I had a Job posting out on the Alberta, Canadain & New Zealand PGA website for an Assistant Professional for the 2019 season. Unfortunately this has been unsuccessful as of now.

I have been able to secure River Sleno for the 2019 season, River worked for us last year and worked out really well for the YKGC. Happy to have River coming back for 2019.

River's cousin has also been offered a position at the Yellowknife GC, he will be either on Grounds & Maintenance or in the Pro-Shop for the season.

Cole will be returning to the Yellowknife GC, Cole has informed me that he has commitments that will limit his availability to the Yellowknife GC this summer. At this point I am unsure of how many hours/days we will have Coles services for each week but will still have Cole for his coaching service for the membership and Juniors.

Corporate Tournaments –

Tournaments have started being booked and confirmed for the season, Hub International being the first of the large Corporate Tournaments start on May 31st.

This year I would like to move Corporate starting times from 12:00pm to 1:00pm, this will allow members to get 18-Holes in before the event starts. As well, it may make it easier for players to work half a day before playing the corporate tournament. This will hopefully increase the number of players attending the events = more cart sales, green-fees and merchandise sold.

I would also like to explore the pricing of corporate green-fees for the day, and potentially look to change this from per-person green-fee to a "course rental fee". This fee would be based on a set number of green-fee players per event.

Example; Numbers can be reviewed and changed.

18-Hole Tournament - \$3,000.00 (5hrs of course use)

9-Hole Tournament - \$1,500.00 (3hrs of 9-hole use)

This structure will eliminate the tournaments that have 100+ players and the GC only gets paid for 40 green-fees due to being mostly members. Also will provide event organizers with a clear amount to budget for.

Advertising & Sponsorships -

Currently working on different options for advertising at the Yellowknife GC, currently we have the following available

-GPS Advertising - \$999.95 Per Year

-Side Decals of Power-Carts - \$2995.95 Per Year for 9 Carts (needs to be reviewed)

-Tee-Box Hole Signs - \$999.95 Per Year, \$2k for 3-Years

-Bench Sponsorship - \$300.00 Per Year

My goal for 2019 is to sell \$20,000.00 worth of Golf Course advertising, through all these advertising streams. If anyone has some ideas of different advertising opportunities, I am all ears.

The last few years, we have missed out on having tournament sponsorships, I would like to start to build relationships with local business's to get back some sponsorship for our club tournaments and work with Clem to build our events back up and grow the interest in tournament golf.
